### Narrative

On 1-31-07 at approximately 2340 hours, I was in a regulation uniform in a semi marked police vehicle. I was parked at about the 16600 block of Pima Rd. on the west side facing east. This enabled me to observe vehicles traveling southbound on Pima from Bell Rd.

I observed a southbound vehicle on Pima Rd in lane two of two southbound lanes. I estimated its speed at 65 mph in a 45 mph zone. Radar showed its speed at 65 mph. This is an open area. As the vehicle passed my location I activated my emergency lights and exited on to the roadway. The vehicle began to decelerate and stopped just north of Frank Lloyd Wright.

I contacted the driver and asked for his license, registration, and insurance.

The driver was identified as William Douglas Parker 10-31-61 with a photo Arizona Driver's license # D00 as it appears on the citation.

Parker stated that his D.L. status is valid. He knew I stopped him for speeding. He believed the speed limit was 40 miles per hour and he did not know his speed. He was coming from, "The Bird's Nest" and on his way home. I asked him how much alcohol he had consumed this evening. He told me, "Three beers." He had the beers within the last two hours.

When we got to the front parking lot of District Two I handcuffed Parker to the front and gave him his cell phone. I had him sit in the rear seat of my vehicle. I told him he could call \_\_\_\_\_ or anyone else. He dialed \_\_\_\_\_ number at 0010 hours. I closed the door of my vehicle and stood outside providing him with a private conversation. I told him to knock on the window when he was done.

Parker knocked on the window at 0013 hours. He told me he was advised to take the blood test and agreed to do so. I asked him if he would like to make any more calls and he declined. I took Parker inside the community room and the blood draw was done without incident.

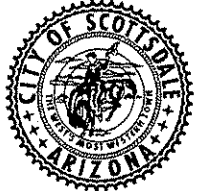




