Todd, you requested info on Terry Clark and so far there is very little. I've checked the Corporations, Business License databases, and I'll check worker's comp with DOL and Corporate Net Income payments to DOR. Terry Clark (unless he holds an Indiana address and part-owns Capitol Construction out of Juneau) doesn't show as a partner or business owner of a current business.

Under Eagle River Roofing, business license # 900313, I don't show Clark's name on the record, but rather Steven Benson (Chugiak, AK), and Tanner Benson (Cooper Landing, AK) on the record.
