The undersigned is informed and believes that:

COUNT 1

On or about February 3, 2003, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by PHILLIP HARVEY SPECTOR, who did unlawfully, and with malice aforethought murder LANA CLARKSON, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

"NOTICE: Conviction of this offense will require you to provide specimens and samples pursuant to Penal Code section 296. Willful refusal to provide the specimens and samples is a crime."

It is further alleged that said defendant(s), PHILLIP HARVEY SPECTOR personally used a firearm, a handgun, within the meaning of Penal Code section 12022.53(b).
